Confirming any service with email, fax or through the concierge and travel agency implies to have read and agreed the terms and commission explained as follows. Notwithstanding any contrary clause, the contract is governed by the provisions of law no. 1084 dated 27.12.77, ratification and enactment of the International Convention relating to the Travel Contract (CCV).

GENERAL CONDITIONS

A specified minimum number required to start any excursion, unless specified. Bookings are subject to place and language availability. Where, due to operational difficulties or reasons beyond its control (travel conditions, strikes, changes in opening hours, closure of museums, delays or other problems), the organization should be obliged to change the program, then an alternative itinerary and/or visits to other museums will be proposed, without any variation to the established tariff, and the client will be informed prior to departure.

In the case of unexpected increases of individual prices, exceeding 10%, as a result of new taxes or duties, the tariffs will be adjusted and the clients notified in writing.

All travellers under the age of 18 must be accompanied by an adult who is responsible for the child's day to day care. Please refer to the child policy of each individual Veronality service for more details.

Proof of age must be available for inspection on the day of travel. If a traveller is identified as

not qualifying for a child price (if a child price is available for the tour), the traveller will be required to provide the balance of difference between the adult rate and child rate for the tour before being permitted to start the trip.

The traveller making the booking is responsible for their own actions and the actions of other travellers included in their booking. If Veronality deems your or the your party's actions to cause danger to other travellers or our staff, interfere with other clients enjoyment of the trip or be deemed to be offensive to the local community and culture Veronality reserves the right to remove you from the tour effective immediately. No refund will be supplied.

The decision of the Veronality guide is final on all matters likely to affect the safety or well-being of any person participating in the trip. If you fail to comply with a decision made by a Veronality guide, or interfere with the well-being of the group, the guide may order you to leave the trip immediately, with no right of refund. You must at all times comply with the laws, customs, foreign exchange and drug regulations of Italy, and you also agree to travel in accordance with our responsible travel guidelines.

Guests grant Veronality express permission to take photographs or make film records of its trips for promotional and commercial use, as well as approving such use by third parties with whom Veronality may engage in joint marketing, without financial remuneration.

PAYMENT

Reservations must be made by filling in our online reservation form or through a tour operator or travel agency.

The reservation is considered to be complete upon payment of a 20% deposit or total amount paid, which must be made while reserving the tour.

The deposit may be paid by credit card or Pay Pal account. Payment is due in full before the tour starts, also on the date.

CANCELLATION

For cancellations communicated in writing at least 7 days prior to the booked excursion date, there is no penalty due, and there will be a refund the total amount.

For cancellations communicated in writing from 3 to 6 days prior, there is a penalty due of 50%, and there will be a refund the balance.

For cancellations communicated in writing from 2 days prior, there is a penalty due of 100%, and there will be any refund.

REFUND

No reimbursement will be granted to any client who is not at the place of departure at the time established; similarly, no reimbursement will be granted to clients who lose contact with the guide or who do not complete the excursion.

Veronality reserves the right to cancel any trip before it is guaranteed to run, a trip is guaranteed to run once it has the specified minimum number of travellers. Veronality reserves the right to cancel any trip, including a guaranteed trip, at any time prior to departure due to terrorism, natural disasters, political instability or other external events which make it intrepid to operate our planned schedule, and in these case there will be any refund.

If Veronality cancels, for other reasons, a trip on which you are holding you may choose between an alternative trip or a refund. The company is not responsible for any incidental expenses that you may have incurred as a result of your booking such as visas, vaccinations, non-refundable flights or loss of enjoyment, etc. If the alternative trip chosen is of a lower value than that originally booked then you are entitled to a refund of the price difference. If the alternative tour chosen is of a higher value then you will pay the difference in price.
